GALLERY ARTISTS SEND WORD...

Donna Rossetti-Bailey, of Marshfield, MA won an Honorable Mention for her pastel painting, *Pink Sky Reflections* at the 2009 Duxbury Winter Juried Show, which is being held at the Duxbury Art Complex Museum, Duxbury, MA, through April 26, 2009. She also won an Award of Excellence at the North River Arts Society Members show for her pastel painting *Sundown, #2*. In addition, Donna has been selected for Kennedy Publications book, *Best of America Pastel Artists Volume II*, which will feature the work of some of America's most outstanding pastel artists. Other award winners at the Duxbury Juried Winter Show included: **Stephanie Roberts-Camello** (1st Place-Mixed Media); **Dianne E. Miller** (Honorable Mention-Mixed Media); **Lilly Cleveland** and **Wendy Hale** (Honorable Mention-Watercolor) **Danguole Rita Kuolas** (1st Place-Printmaking); **Susan Denniston** (2nd Place-Printmaking). **Maureen Brookfield's** watercolor painting *Scituate Sunrise* is featured in the March issue of *South Shore Living* magazine in the Last Page Here segment. Her painting *Golden Pears* won and Honorable Mention in the Cape Cod Art Association's Juried Show *Interpretations of Light* February 19th—March 10th. Cambridge Art Association exhibition *Stratum* held 2/27—3/27/09 and juried by Camilo Alvarez of Samson Projects awarded a Juror's Choice to **Mary Wilkas** for her mixed media encaustic *There rolls the deep where grew the tree O' earth what change has thou seen*. **Ruthe Sholler** received second place in mixed media in a juried show at the Art League of Bonita Springs, Florida. She has a month long exhibit of ten works in the Main Administration building for Collier County, Naples and is teaching an in-service workshop to teachers from Collier County. **Chuck Lathrop** was included in a show called "Flirting with Chaos: Works on Paper" at the Artists Foundation Galleries in Boston. The Damariscotta Lake Watershed Association (DLWA), a Maine land trust organization, has announced that **Anne Heywood's** original painting, *Chimney Farm, Winter* will be the grand prize for their 2009 fundraising raffle. General Electric's Curatorial Team has chosen Anne as a featured artist for their Women's History Month Art Exhibition, held at GE Headquarters in Connecticut. Heywood will have four original paintings in that show, which runs from March 1st to April 30th, and which will also be featured on the GE Cultural Online Gallery. Anne participated in a jury panel of five artists, who chose over sixty pieces from 120 artists worldwide for the National Association of Women Artists Small Works Exhibition. **Patricia McCarthy** and **Carole Thurlow** were participants in the Von Liebig Art Center fundraiser in Naples, Florida this February. The artists painted en plein air along the scenic Third Street South district and displayed works at the annual exhibition and gala.
