Karin Rosenthal

Karin's nudes have been published and exhibited internationally and are represented in 16 major collections including the Boston MFA, Brooklyn Museum, Santa Barbara Museum of Art, the Fogg, Rose, and Danforth Art Museums, and the Yale University Art Gallery. She has received several grants and prizes including Grand Prize in the 2010 Renaissance International Photography Competition, First Prize in Nudes for the 2010 Julia Margaret Cameron Awards, and the Ultimate Eye Foundation Grant for Figurative Photography. A book, Karin Rosenthal: Twenty Years of Photographs, was produced for a retrospective of her work at the Danforth Museum in 2000. She recently had a year-long exhibition at MIT's Center for Theoretical Physics, co-sponsored by Boston's Photographic Resource Center.

Karin has photographed the nude in nature for over 30 years and, since 1996, has led students at all skill levels to discover the genre in original and personal ways. In addition to teaching workshops, she conducts print critique classes in her Watertown studio. Karin is a Resident Scholar at Brandeis' Women's Studies Research Center.

South Shore Art Center invites entries that offer original, distinctive, imaginative imagery, employing photographic media.

ELIGIBILITY: Open to all artists. No geographical restrictions. Work must be recent and not previously shown at South Shore Art Center. **ALL WORK MUST BE FOR SALE.**

SPECIFICATIONS: Two-dimensional work must be suitably framed and firmly wired. No sawtooth hangers, no sandwich frames. 3-D should include a sturdy pedestal.

ENTRY PROCEDURE AND FEES:

Jpeg Digital Files: Up to five works may be submitted as jpegs on a CD. Image files should be 1200 pixels in the largest dimension, 300ppi. CDs & digital files should be clearly labeled/named starting with the artist's name, numbered corresponding to the entry form. (i.e...Baker_1Untitled) Please limit naming convention to no more than 30 characters. Submit files that can be read on both Mac & PC.

Artists Statement/Bio/CV: Must be in printed form. Please do not send electronic files for Artist Statements, Bio & CV.

Fees: \$25 for up to 3 entries, \$35 for 4, \$45 for 5

SALES: ALL WORK MUST BE FOR SALE.

South Shore Art Center receives 40% of the purchase price. No accepted entry may be withdrawn prior to the close of the exhibition. No pricing changes will be allowed after acceptance.

LIABILITY: South Shore Art Center will insure work accepted to the extent of 60% of the artist's stated value while the work is in the Art Center's custody and control.

AGREEMENT: Submission to *Photography NOW*, constitutes an agreement with all conditions of this show. South Shore Art Center reserves the right to photograph an accepted work for publicity purposes. South Shore Art Center reserves the right to reject any work not resembling the submitted entry or work that is not ready to be shown according to the aforementioned specifications.

DELIVERY AND RETURN OF ACCEPTED WORK:

Work may be hand delivered or shipped. For a handling fee of \$25, South Shore Art Center will receive and return work to participating artists. Instructions will be sent to those artists whose work is accepted.
